Tempore for the Town of Paradise Valley by the Town Council in 2003 and was recently reappointed. Larry is a member of the Arizona Magistrates Association.

Larry King's leadership potential was recognized in Arizona, when he was selected to be member of Valley Leadership Class XI. Larry was later selected to be on the Board of Directors for Valley Leadership.

A skillful negotiator, a pragmatic bridge builder and past highly successful Chairman of the Southwestern Business Finance Corporation, Larry King strongly believes in the promise of America and aggressively advanced the mandate of the company to make SBA 504 loans to stimulate economic growth and create new jobs and opportunities for Arizona residents in the company's
